ROLE OF AIGA FOR SUPPORTING PATROLLING GROUP FOR BUILDING CO-MANAGEMENT IN TGR.

Introduction:

Teknaf Game Reserve, as a part of Teknaf Peninsula, is located in the country's far south -east corner, near Myanmar border. It was established in 1983 over a reserved forest (RF) area of 11,615 ha or 116.15 km² located in the Cox's Bazar South Forest Division. It is made up of 10 forest beats over three Forest Ranges, namely Whykong, Shilkhali and Teknaf. It is under the jurisdiction of Teknaf upazila of Cox's Bazar District and lies in between the Naf River on the eastern side and the Bay of Bengal on the western side. The GR is part of a linear hill range (reaching altitude of 700 m), gently sloping to rugged hills and cliffs running down the central part of the peninsula, with a north-south length of nearly 28 km. and an east-west width of 3-5 km. (Mollah et al 2004). TGR covers four unions of Teknaf upazila, namely Whykong, Hnila, Teknaf, and Baharchara. The forests of Teknaf are located in the high rainfall bio-geographic zone and so comprise wet evergreen and semi-evergreen plant species.

Teknaf GR has three Co-Management Committees (CMCs) and 14 Community Patrolling Groups (CPGs) formed for forest resources protection purposes. Each CPG consists of 42 members (except one which has 49 members) who work in shifts such that there are seven small groups of six-seven persons and each group works one day a week.

NSP has also formed 102 forest user groups (FUGs) that have 25-40 members in each group in order to reduce people's dependency on forest resources in and around TGR. Out of these FUGs, approximately 40 are all-female groups. NSP has formed these CPGs and FUGs with the consultation of FD and CMC. NSP has been working there for last more than three years.

In addition, NSP is providing different AIGA (Alternate Income Generating Activities) support to both groups in order to reduce their dependency on forest resources. The AIGA supports are categorized in following ways:

Agro forestry based AIGA support:

- a) Cow patenting activities.
- b) Nursery establishment/Plant distribution.
- c) Home Gardening/Vegetable gardening.
- d) Poultry rearing/Chicken support.
- e) Fish culture/pond culture.
- f) Dry fish processing.
- g) Mush room culture.
- 2. Energy saving based AIGA:
- a) Improved oven program

- b) Bio-gas plant.
- 3. Eco-tourism based AIGA support:
- a) Rickshaw/ Van
- b) Eco -tour guide
- c) Information centre at Teknaf.
- 4. Culture based (Ethnic community) AIGA support:
- a) Pig rearing.
- b) Hand loom.

The provision of AIGA support by NSP to these different groups has been variable. Members of patrolling groups, which are thought to contribute considerably more to forest resource conservation, receive individual support, which is worth Tk 3,500 to Tk 5,000 each. On the other hand, members of FUGs receive benefits that are valued at about Tk 500 per person. In addition, the FUG members are only using AIGA option, home gardening, while CPG members have a choice of 20 possible AIGA. The contribution of FUGs to conservation is generally thought to be less than that from CPGs. This study aims to explore this further, and also determine if these AIGAs actually meet their goals of economic upliftment of the CPG members, and reduction of forest dependency in TGR. Another objective of the research is to investigate whether or not this process is sustainable. NSP is also planning for special support to hardcore poor, specially the female. They may be included as the members of FUGs and their skills will be supported through small grants like basket making, net making etc.

Objectives:

The objectives of the research are following:

- 1) To intervene the better options of AIGA and FUG support provided by NSP.
- 2) To evaluate the AIGA support is contributing in economic upliftment and reducing the dependency of supported people on forest resources or not.
- 3) To assess the sustainability of the AIGA support.
- 4) To assess the capacity buildup of the AIGA supported persons in forest resources protection.

Methodology:

The study will be conducted in two phases. Primary and secondary data collection in the first phase while data analysis and report writing will be completed in the second phase.

Secondary data collection will be done from literature, brochures, and websites. The secondary data will be used in order to develop the methodology further, and in order to understand previous works done in the area. TGR area and NSP site offices will be visited in order to conduct site reconnaissance surveys. The information from these will be used to select potential sites / villages for sampling.

Primary data collection will be done using interviews conducted at various levels explained below. I will use individual interview of FUGs and CPG members, and strategic focus group

discussions (FGD) with Forest Department and NSP field officers, CMC members and non-NSP stakeholder villagers at different level in order to address the research questions.

The number of individuals per FGD will be determined according to site conditions. Semi structured & open-ended questionnaires will be used in order to address the research questions.

To interview FUG and CPG members, I will first identify the AIGAs implemented in each range. Then, I will find out which AIGAs are practiced in all 3 ranges and select 3 options common to all three ranges. Nine CPG members will be chosen in each range such that there are three members in each AIGA option. For the FUG members, I will randomly select three persons in each range (all are carrying out home gardening).

Member of the 14 community-patrolling group, 42-49 persons in a group (total = 595) I will interview 9 persons (3 in each option of each CMC), total CPGs member interview is 27. CPGs have right to choose one best option out of about 20, which is suitable for him, while FUGs have only one option to choice. Out of 102 FUGs (102*30=3060 members), I will interview 3 members of FUGs in each CMC. Total number of FUGs interview will be 9 and total number of individual interviews will be (27+9) = 36.

In TGR three Co-Management Committee comprising of 19 members, total (19 X 3) = 57. I will conduct focus group discussion with 4 people from each CMC (chairman, vice-chairman, treasurer and one women representative) i.e. total (4*3)= 12 members will be conducted FGD. I will conduct focus group discussion also with 6 Forest guards, 3 Foresters, 3 Range officers who are serving in TGR. I will also conduct focus group discussion with 3 field officers, 2 site facilitators, 1 senior site coordinator and TSPC (southern region) who are directly involved in AIGA support program. Key informants other than NSP members like schoolteacher, ex chairman, ex -members etc. Total FGDs will be 7 (shown in the above table).

In the second phase I will use simple statistical analysis where necessary. Text, table, maps, & pictures will be organized following standard editing of the paper. During the study necessary guidance and supervisory advice will be taken from the supervisor.

Research Questions:

- 1) Who are getting AIGA support?
- 2) Who made the decision for AIGA support?
- 3) How decision was made about AIGA.
- 4) Do everybody of a patrolling group getting AIGA support at a time.
- 5) Do every body of patrolling group have got AIGA support.
- 6) What are the options of AIGA support?
- 7) How much AIGA support is provided to the each individual.
- 8) When the AIGA support provided to them.
- 9) Sustainability of the AIGA support.
- 10) What are the performances of AIGA supported persons in resource protection.

Time line:

Considering the time limit of six months following tentative time line has been proposed for the study

- 1) Collection of secondary information 120 days.
- 2) Field visit and primary data collection 90 days.
- 3) Data analysis and report writing: 30 days.
